## Operator's Report

- Dustin Kisting informed that Board that Dewayne Paul and Tony Sonnier from LRWA came and starting checking our water lines for leaks. They found a ¾" line that had broken in half at a meter that was not on our maps. We were losing close to a million gallons per month.
- He said the LA One Calls are in for the leak at a valve on Alvin Briscoe Rd.
- He stated that the pre-lube at the Tower has also been leaking.
- He talked to Rylee Contracting Inc. They will start the Filter's Project on March 17, 2025.
- He will also talk to the Principal at Fairview High School about the project starting.
- He said that Dewayne Paul and Tony Sonnier will be back on March 19, 2025.
- He said that Reggie Babineaux, LDH, called about the sample site at King Hobb's Rd, and Watergate Rd.

#### **New Business**

- Penny Johnson, Office Manager, told the Board about the Red Flag Rule. She handed out a policy from another water district for the Board to comment on.
